## OF VITAL IMPORTANCE

For the past 38 days, a main topic of debate in the Senate has been the Civil Rights Bill. To keep Marian students informed, the following series of articles will present a summary of the proposed bill. The bill is composed of 11 sections which cover a variety of subjects. This issue deals with the first twose.

#### 1. PROTECTING VOTING RIGHTS

Summary - to further protect voting rights in Federal elections, it would prohibit: (1) the application of different tests, standards, etc. to white and colored voters and (2) the denial of registration for immaterial errors in applications. It would require all literacy tests to be given in writing or transcribed. To expedite handling of cases filed under the 1957 and 1960 Civil Rights Acts, it would authorize the Attorney General or a defendant to ask for a trial by a three-judge court, with direct appeal to the U.S. Supreme Court. In any such proceeding it establishes a presumption of literacy for those who have completed the sixth grade.

## II. RELIEF OF DISCRIMINATION IN PLACES OF PUBLIC ACCOMODATION

Summary - It would prohibit discrimination in most hotels, motels and other places of lodging; restaurants, cafeterias and other eating places; motion picture houses, theaters, sports arenas, stadia and other places of exhibition and entertainment; gas stations; and such places as specialty shops and barber shops in hotels subject to this section and stores with eating facilities covered by the bill. An aggrieved individual or the U.S. Attorney General would be be able to enforce these mights through injunctions or other civil actions. There is a specific exemption for small rooming houses with no more than five rooms to rent and used by the proprietors as their own residences.

RETREATS? ? ?

It's that time of the year again when Marian students reush to the city's two retreat houses to meet the May 1st deadline. It's also the time for the most vociferous cries of anguish. Mhy??? Several reasons are to be given: some students resent the idea of a compulsory religious exercises; some, the money and studytime "lost"; others resent both. Are the complaints justified?

No one can question the right of the administration to require an annual retreat of all students. But whether the right should be used or not is the question. If the administration thinks that most of the students are devoting a weekend solely to God, I think that the administration is falling prey to wishful thinking. The facts belie such thinking as the administration must surely know from some unpleasant experiences in the past. Students may give a weekend to God, but to God and to the textbooks. Is this really the proper spirit for a retreat? Of course not. But it can scarcely be expected of students to part completely with the books for a weekend, especially if these students are juniors and seniors who have numerous papers and outside readings--- implicit in upper-division courses to do.

I don't like the idea of a compulsory retreat and I don't think most of the other students do, but the idea should not be ruled out completely. A more practical policy would be to require one retreat of all students, and this to be in their first year at Marian. In this way, those who had never made a retreat, and who perhaps never would, could have at least this one experience. Any retreat there after would be entirely of their own choosing.

At the least, the situation as is warrants some realistic rethinking by the edministration on the whole idea of a compulsory retreat.
