From the Masses:

To the Carbon and the College,

I wish to take exception to the parody-verse penned by the editors of the Carbon in the last issue; specifically the stanza that maligned the intelligence of the Bootstrap student at Marian. It is simply false that as a group they are inferior intellectually to the general run of students at Marian. What is true is that they are discernably much harder working. There is a real issue at stake in the matter of the Bootstrap program and the FAA program, but unfortunately the editors did not raise it. To wit: How will such programs affect the character of the college as a four year undergraduate liberal arts institution? I happen to support both programs, (and as a member of the Adult Education Committee participated in the work that saw each established) but I recognize the legitimate worries that such programs give rise to in the minds of some faculty and students, especially the FAA program. The Carbon might have raised the issue which, I think, was really the editors

concern anyway. Finally, I think it regrettable that first, the present editors stint, which is both courageous and accurate in many respects ended in the note that it did and second, that so many in the Marian Community who differed with the editorial view of the Carbon neglected their responsibility to use the letters to the editors designated to make their objections public. This should have raised the level of dialogue thus benefiting to that of reasoned discourse.

To the M.C. community:

Concerning the Editorial verse about the G.I.'s, in last weeks Carbon, we are sorry that it seems several men on the Bootstrap Program took it so personally. For that reason we apologize to them, for the statement, "but have no brains to show" was clearly false.

It should be evident that the parody was a satire and not meant to be taken seriously as evidenced by the following line "Seriously though . . ." (We hope no one believed we were really thankful for Dr. Gatto's note or for calls into Dean Brames' office). Sarcasm and satire can't be banned just because some people are offended. (Often they deserve to be offended, though not in this case). However in the present situation some have questioned whether it was satire or libel. Last night a representative of the men on the Bootstrap program threatened personal suit and the elimination of the Carbon. On this short notice we were unable to consult a lawyer. If it was libel we would retract it, though this is still open to question. The verse was a generalization and not directed against any person. In any case, something that was not meant to be taken seriously, should not have such a serious effect.

To the M.C. community:

In last week's Carbon, Dr. Adams brought to our attention a possible disparity in the number of class days between the fall and spring semester of the upcoming academic year. According to his calculations, the proposed length of the spring semester would exceed that of the fall semester by five class periods.

While I agree wholeheartedly with his concluding puzzlement as to how some local people arrive at these and other decisions (I have been befuddled more than once in the recent past at the rationale behind several decisions made at Marian), I would like to suggest a different perspective on his argumentation of this issue, a perspective which I fail to discern in Dr. Adams's remarks.

My own personal reaction to the possible disparity in question is of what Dr. Adams calls the "who cares?" variety. But it is a "who cares?" based on the conviction that a course is something more than a series of discrete sitting sessions. Dr. Adams asks, "How can Marian College offer two semesters of unequal length and give equal credit to both?" This question rests on the assumption that unequal length implies a significant difference in the content of a course. But surely any given course is (or ought to be) controlled by a qualitative unity of content as well as a quantitative number of meetings. If so, then it is conceivable that a quality course could be offered in a single hour session (I cite as an instance the excellent "course" on the nature of holiness presented in Plato's Euthyphro). This kind of qualitative unity is conceivable, but clearly it is impractical. Yet it should be pointed out that it is impractical only on the unquestioned "bookkeeping" standards of contemporary educational organization (numbers of courses, credit hours, majors, minors, etc.). The danger here is that the importance placed on the numerical will submerge the equal (and, in the artless simplicity of my own mind, more important) feature of the unity of a course. Speaking for myself, I would not care a pin if I had to teach the same course in consecutive semesters when there was a disparity of five class meetings (or more) between the first and second semesters. The only problem would be to arrange the rhythm of topics covered so that in each semester some sort of unified course was achieved. If this approach is sound, then it is not really relevant to ask how the college can give credit for the same course if its length is unequal. The answer is that it is the same course, but that the unity of the shorter is different than the unity of the longer. Now perhaps Dr. Adams does not disagree with this argument, but my impression was that the qualitative perspective was not in the content of his letter. And, as I mentioned, it seems a relevant feature of the issue.

A Naughty band of pilgrims, clearly in need of a remission of their sins, will march, ride and roister their way through the musical called "Canterbury Tales" at the Marian College Theatre for three performances May 4, 5, 6th.

The musical, which won fanfares of praise when it was first presented in 1968 and then in New York in 1969, is a modern rock 'n' roll song-and-dance show derived from Geoffrey Chaucer's 14th century collection of tales that a rowdy group of travellers told one another on a pilgrimage from London to Canterbury Cathedral, to be absolved of their sins by visiting the tomb of St. Thomas a Becket. Judging by the spicy stories they tell one another at a stopping place on their journey, they have a good share of sins to account for.

"Canterbury Tales" has been a classic of rich language and rich bawdiness since Chaucer wrote his 23 stories in rhymed couplets in 1385. Four of them are incorporated in this new musical that is embellished with 24 songs and a great deal of skylarking and high-spirited dancing.

Under the direction of Professor Don Johnson, a cast of thirty will sound out the effervescent gaiety of the show, with the major roles in the hands of Marty Risch, Dan Kernan, Greg Rodick, Alan Roell, Carlos Barbera, Patty Kane and Margie Freeland.
