EDITORIAL:

This letter is in regard to the bizarre housing policy that now exists at Marian. As you are probably aware by now, Student Services has begun their gestapo tactics early this year. Letters seem to be all over the city with the Dean's name scrawled across the bottom. How does one go about receiving such a collector's item? Move off campus illegally.

In a taped interview with Dean Brames at 8:30 Thursday morning, the housing policy was discussed. As usual, what it amounted to was "economics".

The question was posed to the Dean concerning the dorm enrollment. He said that a dorm only partially filled is a determining factor in who shall be allowed to live off campus. However, it is not a main factor. What is?

He was very informative in the interview. He said that the reason for the high age limit of 22 for moving off campus legally is to insure full occupancy. He will soon have it because no one can move off.

What I am most concerned about is the way which the final decision is handled. If we are not satisfied with a negative decision,

STUDENT BOARD REPORT

The Student Board met Sunday, Sept. 26 at 7:00PM in the Social Council Room. Pam Murray was selected Student Board representative from the Academic Affairs Committee and Ed McCord from the Student Services Committee. The selection of Day Student Representative was postponed another week. Any day student wishing to take this position may still apply by telling any Board member and coming to the next Board meeting. Day students who use the Perc and/or the Cafe are also needed for the Food Services Committee and should give their names to a Board member to submit. Treasurer Mike Mottram explained several new budget procedures. Social Council will be ultimately responsible, financially and otherwise, for social activities. Clubs and organizations are only to sponsor activities which further their own function and should submit budgets for these activities. Classes will no longer be given a set amount per person but are asked to submit budgets for their own activities. Organization and classes should no longer feel obligated to sponsor money making events. Likewise, classes will not be expected to fund their traditionally-sponsored events such as Sweetheart Ball, Sadie Hawkins, etc. In another area it was

Editorial (cont.) we can take it to the President. He in turn decides whether to uphold the decision or not. The President has done this without consulting the student involved. I know that in the case of Don Sartino and myself that we both tried to have the decision appealed. On the day of our interview, we were informed that the President had decided to uphold the decision (without seeing either of us). Is this an appeals system? If we are still not satisfied, we can ultimately go to the Board of Trustees. As the Dean pointed out, we don't want to take everyday, mundane problems to these busy men. I wonder how the mundane items such as the dress code and women's hours find their way to the Board.

It should be noted that Student Services does make exceptions. I am an exception, and I wonder to this day how it finally came about. Apartment living has been valuable to me -- moreso than the dorm ever was. I could elaborate on the money saved and the experiences gained, but why bother? Student Services is more qualified than actual experience.

In closing, I would like to commend Don Sartino on his principles (as of the negative decision given him he has withdrawn from school).

ANOTHER EDITORIAL:

Dormitories were built to provide housing for students who had come from other towns and had no place to live near the college. In this, dormitories are a definite service, providing room and board for these students.

The Marian College Housing policy is stated:

"All single undergraduate students who do not return to their parents', guardians' or blood relatives' homes each evening are required to live in College housing. Students who have attained their 22nd birthday on or before September 30 may live in housing of their own choosing."

In an interview yesterday Dean Brames said, "Marian or any other institutions set Housing Policies which tend to help insure that there will be full occupancy in the residence halls." As far as I can see this is the major factor in the setting of Marian Housing Policy. The necessity of a full dormitory in order to be able to pay for it may be a valid justification for such a policy, but this is not stated in the handbook. Rather the policy is hidden behind a statement of the educational value of the dormitories:

"Marian College considers residence hall living to be an integral part of the educational development of students....The College views a resident's experience in group living as an opportunity for learning to live and work amicably with others of varying ages, cultural backgrounds and tastes."

However "learning to live and work amicably with others" often turns out to be a case of not learning to respect the rights of others, but rather to put up with the excesses of others. It is easy to see how after a few years the dormitories are no longer a service but a detriment to some students.

People who find it impossible to live

Board Report (cont.) decided to change the yearbook from Student Board funded to a self-sufficient status by seeking subscriptions from those who wish to receive it. Another proposal was discussed though not decided, to give the theater department an annual fee which would permit all students to attend theater productions without charge. Mike Mottram, John Purcell, and Vince Ryan were appointed as Budget Committee, with one more person to be appointed by Social Council, to begin to formulate this year's budget. Progress reports were made on the Publications Board Constitution, Student Board Constitution, and the Policy on Open Events. The next Student Board Meeting will be 7:00PM this Sunday, October 3.

Another Editorial (cont.) with this seek off-campus housing. Besides being cheaper and quieter, they often see it as a real educational experience. It is the experience of being responsible for yourself; providing for one's own housing, food, upkeep, etc. The final benefit may well turn out to be an increase in maturity, which a dormitory system is unlikely to provide.

A college which seeks to help the student in "acquiring experiences and skills needed to pursue his chosen course in the world" must find a solution to the conflict between financial necessity and allowing students to develop their whole potential.

The following is a personal letter to help clear up a number of the questions concerning the 1972 yearbook.

In past years the yearbook has not, in my opinion, adequately and effectively covered the events surrounding Marian College. Our hope for the 1972 yearbook is to publish a thorough and comprehensive annual.

But the Student Board has raised some problems and we need your help. We have been cut from the Student Budget due to the following reasons:

1) Mis-managed funds and repeated debt in former years.

2) Apathetic attitude on the part of the students for compulsory purchasing of the yearbook for each full time student (previously included in the Student Activity Fee). Consequently:

One-third of the Student Budget formerly given to the "Marian" is now being channeled into various student body activities.

Therefore a fee of \$6.25 is required if publication of the book is to be made possible. Total student support is needed and anyone wishing to help would be whole-heartedly welcome. The Yearbook subscription drive is October 8 to October 15.

Your comments and criticisms are welcome and needed, please feel free to contact me or a member of the staff.

In recent conversation, I was made aware of the difficulties imposed upon students that belong to the Work Study Program. It appears that they have been misled by the Financial Aid Office at Marian College. Last Spring these students filled out the Student Application For Federally Insured Loan's (Form OE 1154 5-67) On this form was the amount they were "told" would be made available to them on work study. Shortly before the academic year 1971-72 this agreement (signed by Miss Jeffers) was made void by the Financial Aid Office. I was previously under the assumption that an agreement between two people, which was signed, could be termed, a contract. A contract is binding unless both parties agree to cancel the terms within. Now what student would make such a blunder as to cancel this agreement? Does this mean that this institution of higher learning breaks contracts? (Absurd, signed agreements are never varied, i.e. Housing Policy) In light of the fact that students must be so explicit in their dealings with this administration, I feel we should be extended "similar courtesy".

I am not fully aware as to what legal ground this could be pursued, but if I were in such a position, I would exhaust all possibilities (due to the explicit details laid down for Protest on Campus, this would have to be a peaceful search).

In future dealings, the director of the

In the midst of the general furor over the right of students to live off campus if they are under 22, I would like to take a position concerning an exception to this rule. The exception is if a student has served two years in the armed forces he (she) is deemed mature enough to live in a socially integrated situation.

This exception has to be absurd. Certainly the person who has served two years in the service has lived under enforced social dictums. Of course the person has been subjected to "righteous" community living. In either case the mode of living was enforced under penalty of imprisonment. In most cases, from personal observation, this forced style of living was scarcely tolerable.

The obvious reaction to the military dominance was to act in a manner that could hardly be deemed socially acceptable to the civilian community.

Now are we to assume that a young adult who has lived in the college community for two years in what could probably be called a harmonious communal existence is too immature to share an apartment with a close friend or friends? Young adults all over the country are being given more responsibility in areas of government and vocational position. I don't think one would have much trouble finding many examples of 20 year old adults living in a perfectly acceptable manner without the benefit of 2 years of collegiate matriculation.

In conclusion, I would appreciate knowing just exactly why adults of the age of 20 should still be coddled at the breast of "mother college".
