Letter to the Editors of the Carbon:



### STUDENT BOARD REPORT

A regular Student Board meeting was held Sunday, November 17, 1974 at 7:30 in the Social Council Roem.

### Reports :

Social Planning: A meeting was held and plans for a Christmas Party were discussed. A woman from Leonard and Reese talked to Theresa Bellas about discounts on entertainment.

#### OLD BUSINESS

Dr. Sharp explained the Teacher Evaluations planned by Purdue. They applied for a grant from the Lilly Foundation to be able to help smaller colleges to get this program started, and they were given a grant which will allow Marian College free of charge for two years.

It is called the "Cafeteria System" and allows each proffesor to choose his own questions. No one but the proffesor will receive the results from the evaluation forms.

The Proffesor is given approximately 200 questions to choose from. He picks which ones he would like to see on his particular form, and sends these questions back 'to Purdue. Everyone has the first six questions dealing with class status, sex, required class or not and se on. The last five questions are also the same on every form, but the rest are left to the discretion of the proffesor.

Purdue then processes the questions and mails back answer sheets, computer process sheets, instructions and pencils. After a class answers the questions, they will be mailed back to Purdue. The entire classes score will be broken down and given a median score.

### FROM THE MASSES CON'T

Will there be a riot on campus next week? Probably not, but in my two and a half years at Marian, I have never felt a more conducive atmosphere for rioting than I do at present. I cannot and willnot attempt to speak for other segments of this campus, but I would like to speak of the general atmosphere of Doyle Hall, of which I am a resident.

In Doyle Hall there seems to be an increasing mistrust toward certain segments of the college administration, especially the Office of Student Services. Many feel the title Office of Student Services is a misnemer, it would more correctly be named Office of Student Harassment. In Doyle recent rumors are abundant that the RA's are under pressure to search out violations of the college policies, and their failure to reach an adequate quota could very well jeopardize their jobs. To my knowledge, these rumors are not based on any fact, but the trouble with rumors is that if they continue to persist, they are soon taken as fact.

The foremost issue at Doyle at present is the right of an R.A. to enter one's room unannounced and once inside having the right to search through closets, drawers, etc. When asked by fellow residents of the legality of this invasion of privacy, I could not adequately answer. Now I can. There is a section in the Residence Life 1974-75 which reads in part "...a designated college official may conduct a search of the college premises if there is a reason to believe that such premises are being used for illegal purposes, for a purpose which interferes with the normal operation of the college, or in violation of health and safety regulations. Whenever possible room searches will be made in the pre-sence of the resident(s)." As to the legality of this clause I found that the courts have held that a student living in a dormitory on college premises relinquishes certain constitutional rights. The one pertaining to the search is the fourth amendment. We do not have the full protection of the fourth amendment as do other citizens. This to me is very sad, but unfortunately, very legal.

One of my main reasons for writing this letter to the Carbon was to inform residents who might have been in doubt, as I was, of the legality of room searches, that it has "xisted in the past, does exist at present, and is perfectly legal. It is not something trumped by the dean or anyone else to crack down on this year's residents.

As to other parts of the letter concerning negative rumors, I hoped to point out that the residents of Doyle are not passive objects which sit motionless when abused. Talk of a mass disobedience of a school policy and of sending a letter to every high school publication in Indiana describing the undesireableness of Marian College are not the actions of passive objects. These topics of action have been seriously discussed.

There have been rumors that Doyle Hall is occupied by irresponsible students who, unchecked, constantly abuse school policy. This is not true. These rumors are also not based on fact. I personally do not believe that Student Services is out to fill quotas and harass students, but both Doyle Hall and Student Services (cont. next col.)

are viewed by many in a negative sense. As a resident of Doyle Hall, I will do everything possible to clear up misconceptions many have about the dorm. I hope that Student Services will do the same.


